



## 領取環聯信貸報告免費兌換代碼條款及細則

1. 華僑銀行（香港）有限公司（「本行」）已從環聯有限公司（「環聯」）支付一套信貸報告兌換代碼。
2. 於本行成功登記的環聯信貸報告免費兌換代碼及透過成功註冊 TransUnion IDVision（「服務」）訂購線上報告（「服務」）的用戶（「您」及「您的」）可以免費查閱環聯個人信貸報告。本服務僅由環聯提供，本行對本服務的使用不提供任何保證，也不承擔與細節相關的任何責任或義務，包括環聯在信貸報告中提供的任何內容或資訊的準確性或完整性。
3. 您可用免費兌換代碼在環聯網站上免費訂閱三個月的信貸報告。
4. 免費兌換代碼的有效有效期至 2025 年 3 月 31 日。名額有限，先到先得。

## Terms and Conditions for the free redemption codes from TransUnion Credit Report

The Service is solely provided by TransUnion and the Bank does not give any warranty over the use of the Service nor will it be responsible for any liability or responsibility in relation to the details, accuracy or completeness of any content or information provided on the TU Credit Report by TransUnion.
3. The free redemption code shall entitle You a three (3) months subscription to TU Credit Report without charge on the TransUnion’s direct portal.
4. The free redemption code is valid until 31st March 2025, promotion codes are subject to availability and on a first come first serve basis while stocks last.
5. If You have any queries on the Service registration or credit data on the Credit Report as provided for by TransUnion, You have to contact TransUnion directly.
6. The Bank and TransUnion shall not share any Personal Data nor Credit Report of user other than the numerical information of the redemption codes.
7. **By registering for the free redemption code, the Bank intends to use Your name, contact number and email address (“Personal Data”) for promoting financing services of the Bank by our designated staff to You. : (Please tick (“✓”) the appropriate box(es))**

☐ **By ticking this box, you do not object for the Bank and TransUnion to share your Personal Data with each other for the purpose of promoting the Bank’s financial services.**

8. **Subject to clause 7 of this Terms and Conditions being agreed, TransUnion will notify the Bank of the redemption status of the free redemption code, thereby the Bank can follow up on the Service and promoting financing services of the Bank by our designated staff to You.**
9. Any changes to the marketing preference to the Bank to use Your Personal Data for the prescribed purposed in clause 7, You should contact the Bank upon receiving the acknowledgment email/ SMS after registration for the Service with TransUnion.
10. You will be able to view your credit data on the TU Credit Report after having successfully registered for the Service with TransUnion.
11. The Bank reserves the right to amend any of the above terms and conditions from time to time (including charging for the use of the Service of TransUnion which charges are currently paid by the Bank in full). For any and all matters or disputes regarding the above, the Bank’s decision shall be final and binding.

13. In case of discrepancy between the English and Chinese versions of these terms and conditions, the English version shall prevail.
