

"Apple Store Gift Card Offer" Terms and conditions:

「Apple Store 禮品卡獎賞」條款及細則:

- 1. The promotion period of the "Apple Store Gift Card Offer" " ("Promotion") is from 1 April 2024 to 30 June 2024, both dates inclusive ("Promotion Period"). 「Apple Store 禮品卡獎賞」(「本優惠」)之推廣期由 2024 年 4 月 1 日起至 2024 年 6 月 30 日止(包括首尾兩天)(「推廣期」)。
- 2. The Promotion is only applicable to new customers ("Eligible Customers")
- i) who have not opened or maintained (whether in the customer's sole name or jointly with any third party) any loan account (including but not limited to Instalment Loan and Revolving Credit) with OCBC Bank (Hong Kong) Limited ("the Bank") at any time during the 12 months immediately preceding the date of the Eligible Customers' loan application; and
- ii) who have not opened or maintained (whether in the customer's sole name or jointly with any third party) any loan account (including but not limited to Instalment Loan, Mortgage and Revolving Credit) with OCBC Credit (Hong Kong) Limited at any time during the 12 months immediately preceding the date of the Eligible Customers' loan application.

本優惠只適用於全新客戶(「合資格客戶」)

- i) 由申請日起過去 12 個月內之任何時候未曾於華僑銀行(香港)有限公司(「本行」)開立或持有(包括以個人名義或與第三方聯名)任何貸款戶口(包括但不限於分期貸款及循環貸款);及
- ii)由申請日起過去 12 個月內之任何時候未曾於華僑信用財務 (香港) 有限公司開立或持有(包括以個人名義或與第三方聯名)任何貸款戶口(包括但不限於分期貸款、按揭貸款及循環貸款)。
- 3. Subject to these terms and conditions, Eligible Customers who successfully applied and draw down for the instalment loan ("Loan") (excluding decoration loan and education loan) via Online with a loan amount of HK\$200,000 or above during the Promotion Period will be entitled to one set of HK\$500 Apple Gift Card Code (the "Gift Card Code")
 - 受本條款及細則所限,合資格客戶若在推廣期內於網上成功申請及提取貸款額為港幣 200,000 或以上及還款期為 24 個月或以上之分期貸款計劃(「貸款」)(不包括裝修貸款及升學進修貸款),可獲贈一組 HK\$500 Apple Store 禮品卡代碼(「禮品卡代碼」)。
- 4. If an Eligible Customer submits the Special Offer Confirmation or any other instructions by facsimile or email, the Eligible Customer expressly agrees and acknowledges that: (i) there is always a risk of fraud, forgery, lack of authority, lack of clarity, error or delay or partial or total failure in transmission and duplication in relation to instructions transmitted by facsimile or email (including the Special Offer Confirmation), and that, other than taking reasonably practicable steps as the Bank may consider appropriate, the Bank shall have no further duty or obligation to enquire, verify or confirm that such instructions are for the Eligible Customer's benefit, the identity, authority and power of the person giving such confirmation so as to ascertain the same to be the Eligible Customer, and shall be entitled (but not bound) to accept as genuine and act upon any such instructions believed by the Bank in good faith to have been given by the Eligible Customer; and (ii) instructions sent by facsimile and/or over the Internet cannot be guaranteed to be completely secure and may be intercepted. The Bank shall have no liability whatsoever for any losses, liabilities, claims, costs or expenses that may be incurred or sustained by the Eligible Customer directly or indirectly as a result of such submissions or the Bank's reliance upon or compliance with such instruction.
 - 合資格客戶若透過傳真或電子郵件向本行傳輸優惠確認書或任何其他指示,則該合資格客戶特此明確同意及確認:(i)透過傳真或電子郵件傳輸的指示(包括優惠確認書)均時刻存在欺詐、偽冒、欠缺授權、有欠明確、傳輸錯誤或延遲,或部分或全部不能傳輸及重複傳輸的風險,而本行除採取認為適當的合理切實可行的措施外,概無進一步職責或義務去查詢、核實或確認有關指示乃為該合資格客戶的利益而作出,以及作出有關指示的人士的身份、權限及權力,以確定有關指示乃由該合資格客戶作出,亦有權(但無義務)接受本行真誠地相信由該合資格客戶作出的任何指示為屬實並按照該等指示行事;及(ii)透過傳真或電子郵件傳輸的指示均無法保證完全保密及可能被截取。對於該等傳輸或因本行依賴或遵循有關指示而令該合資格客戶直接或間接招致或蒙受的任何損失、法律責任、申索、成本或支出,本行概無需負責。
- 5. The Gift Card Code will be sent to the Eligible Customer's email address provided in the Loan application within 3 months after the date of drawdown of the Loan (the "Redemption Email"). The Eligible Customer is required to redeem the Gift Card Code on the Apple Online Store and at Apple Retail stores. Eligible Customers may refer to the Redemption Email for details. If the Eligible Customer does not receive the Redemption Email accordingly, he/she should inform the Bank within 3 months after the date of drawdown of the Loan, failing which the Eligible Customer shall be deemed to have received the Gift Card Code in accordance with this clause 5.
 - 禮券卡代碼將於合資格客戶成功提取貸款後 3 個月內以電郵傳送至合資格客戶於貸款申請時提供之電郵地址(「換領電郵」)。合資格客戶須到 Apple Online Store 及 Apple Retail Store 兌換使用)。有關換領詳情請參閱換領電郵。若合資格客戶未能按時收妥換領電郵,他/她應在成功提取貸款後 3 個月內通知本行,否則該合資格客戶將被視作已根據本條款 5 獲取禮券卡代碼。
- 6. Notwithstanding anything to the contrary, if the Eligible Customer has made an early settlement of the Loan before receiving the Redemption Email, the Eligible Customer will be conclusively deemed to have unconditionally and irrevocably waived all his/her entitlement and rights under the Promotion. In addition, in the event of repayment of the entire Loan prior to the final loan repayment date, if the Eligible Customer has redeemed the gift, the Eligible Customer is required to pay to the Bank in full the face value of the gift card code and any other fees and/or charges to be paid to the Bank in case of early repayment of the Loan as specified in the Promissory Note and/or OCBC Bank (Hong Kong) Limited Loan Terms and Conditions. The Bank reserves its right to debit such amounts from the Eligible Customer's repayment account without any prior notice or consent.
 - 儘管本文另有規定,若合資格客戶於收取換領電郵前已提早償還貸款,合資格客戶將被終局性地視作已無條件地及不可撤銷性地放棄其於本優惠之一切權利。此外,如合資格客戶在供款期間提早償還全數貸款,合資格客戶如有換領禮品,本行將**收取相等於**禮品卡代碼價值**及貸款合約及/或華僑銀行(香港)有限公司貸款之條款及細則內所述有關提早償還貸款時須繳付的費用及/或金額**。本行保留從合資格客戶的還款戶口扣除上述款項的權利而毋須事先作出任何通知或獲取任何同意。
- 7. All products specified in clause 3 will be delivered by the supplier in accordance with the relevant terms and conditions of the supplier. Should the delivery be delayed or the product be lost (including but not limited to delivery lost), stolen or destroyed, the Bank will not reissue the Gift Card Code and will not bear any responsibility or be liable for any compensation.

- 8. Each Eligible Customer can only enjoy the Promotion once during the Promotion Period. For the avoidance of doubt, the Bank reserves its right not to offer any or all of the aforementioned privileges at its sole and absolute discretion without giving any reason therefor.

By applying for the Promotion, the Eligible Customers agree that they understand and accept the relevant terms and conditions of the supplier (including any privacy policy and/or cookies policy) and agree to be bound by them. Should there be any dispute, complaint or claim with regard to the Gift Card Code, the Website and/or the products, the Eligible Customer should make such demand, complaint or claim directly with the supplier. The Bank reserves the right to replace the products specified in clause 3 with any alternative gifts at any time without prior notice or consent.
